



Dear Speaker Phelan,

When Texans elect lawmakers as their representatives, it is with proper expectation that they will serve with the utmost honesty, integrity and will make well considered decisions that preserve and protect their liberties. When we elect Republicans as a majority, we expect conservative actions and Republican control.

Throughout your tenure as Speaker of the House for the 87th and 88th legislative sessions, you have repeatedly demonstrated your disdain of the Republican Party of Texas's (RPT) platforms and legislative priorities.

Your appointment of 13 Democrats in the 87th legislative session and nine in the 88th to serve as chairmen of key committees opposed the RPT platform and its legislative priorities. Your chairman appointments of members of the LGBTQ Caucus violated RPT Principle 6. Your appointments were instrumental in the failure of bills that would have been of great benefit to the people and businesses of Texas. Not to be overlooked is your appointment of Hugh Brady, a former Obama official as Parliamentarian, violative of RPT Principles 3 and 6.

During the 87th legislative session, when the Democrats fled Texas to avoid passing the election integrity bill you did nothing but reward them with failing to pass good election integrity bills. Your poor leadership has led to no viable border bill, China continuing to buy up Texas lands, no elections bills to arrest known election corruption and no property tax relief in sight due to your "sine die". Worse is your demonstrated disregard for constitutional protections which were blatantly dishonored throughout your entire impeachment process from its inception, including destroying the presumption of innocence and continued tampering with the Senate. Your vote for impeachment violated RPT Principles 1 and 8.
